- **We're truly international.** Only 16 years after being founded, Rotary had clubs in six continents. Today, members in nearly every country work to solve some of our world's most challenging problems.
- **We persevere in tough times.** For example, Germany, Italy, Japan, and Spain were forced to disband during World War II. Yet, despite the risks,

many continued to meet informally, and after the war, Rotary members came together to rebuild their clubs and countries.

In addition, we were leveraging the strength of our combined networks of members to provide comfort and hope to those feeling the effects of isolation and fear.

In these times of uncertainty, the Rotary Club of Strathfield remained committed to meeting the challenge of finding innovative ways to take action together to help communities around the globe heal and thrive - and become more united than ever.


